It aims to create a society where people feel hopeful about raising children and where children's smiles can be seen everywhere.

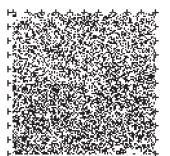

Persons eligible for support

- Children aged 0 to 18 who have an address in Tokyo (*)
- The allowance is also provided when children are temporarily studying overseas.

* Children born from April 2, 2005 to March 1, 2024

In other cases if you are not certain whether a child is eligible for the support payments, please check the above website.

Applicant

If the child is younger than 18 years of age, the application must be submitted by a parent or guardian.



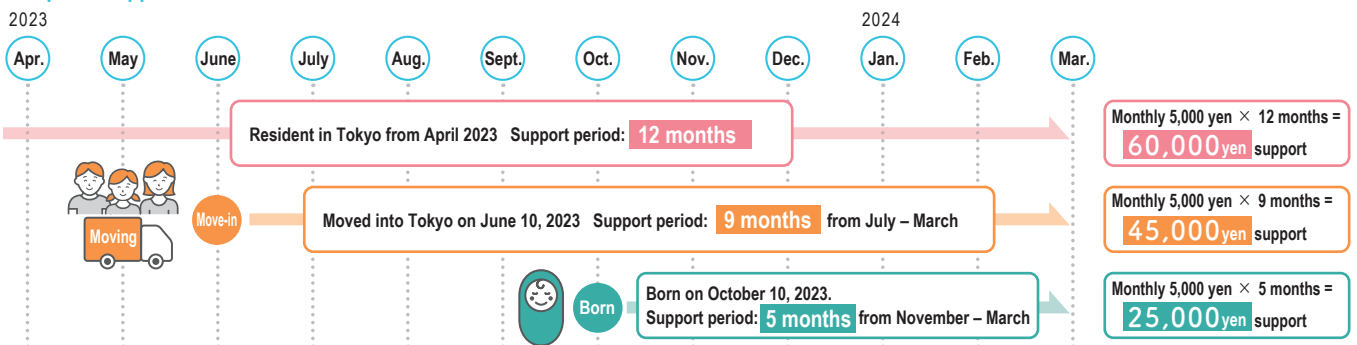
* If the child is 18 years of age, the application may be submitted by a parent or guardian, or by the applicant himself/herself.

* Application by postal mail is also possible. For details, please contact the call center listed below.

Support period and amount of payments

- Verification of your address is performed based on the conditions on the first day of each month.
- Children who moved into Tokyo or were born on the first day of the month are eligible for support beginning from that month. Children who moved into Tokyo or were born on the second day or later of each month are eligible for support beginning from the following month.
- The timing for provision of this support will be announced on the above website or by other means.

Example of support



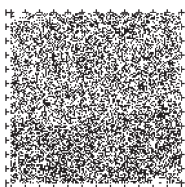
Taxation

When the annual income of the child is only the 018 Support, then the support payments are not taxed.

* When the eligible child has temporary income other than 018 Support payments, or when the eligible child does not live in Japan, the support payments may be taxed.

About the exemption for recognition of income from public income support

For persons receiving public income support, the 018 Support payments will not be recognized as income.
